#### *Treasurer report – Kathleen Nixon*

The account balance is approximately \$23,000. The following purchases have not yet been paid: turf blankets, game clock, and online coaching. Two goal nets have been ordered, but not yet paid for. We are up to date on our Foothills Arena's rental fees but expect more usage before we can be outside for the season. Nate spent about \$1000 on video equipment / IPAD. It was approved that the team fees for coaches' players will be waived as in the past. Kathleen suggested a note for families which explains the difference between the team fees, which the team collects through the website, and the district fees, which is paid through Jeffco Connect. The fees can be confusing, especially for new families. There was a discussion regarding work opportunities families can participate in to help pay for their individual team fees.

#### *Coaches Report – Nate Hallahan*

1. Team Updates – tryouts are going well. It will be a tough decision to decide the final rosters. There will likely be a few swing players, who will dress for both varsity and JV.
2. Off season league – wrapping up. He is happy with the participation this year.
3. Turf Blankets – Will not happen for this season. Will look into for next year.
4. Spring schedule – nearly complete; there are a few final adjustments to be made.
5. Trailblazer Stadium Remodel - Nothing new. It will impact our games for sure.
6. Transportation/buses – The school will set up the buses and we will reimburse them.
7. Uniform Update – New varsity jerseys and shorts. JV will use the old jerseys and the new shorts.
8. Pinnies – Have not yet been received. They are delayed due to the quarantine in China.
9. GMHS Remodel – it is unclear which GM teams will have new fields to practice on after the remodel, so we are planning on a back up place to practice. There will be additional fees our team needs to pay for, such as safety nets. Outdoor lights will never happen due to zoning regulations in the GM area.
