August 18, 2020 minutes approved by Nate Hallahan and Ken Berridge.

Financial Report – Kathleen Nixon

1. We have \$9430.26 in bank account. Apparel has already been paid out. \$1334.50 in school account.
2. \$500 for PPP for Teachers in 2020. A one-time fee will be added in the budget.
3. Scholarship fund was discussed and will be added as a line item in the budget. \$250 was agreed upon.
4. Kathleen will complete another audit with Michelle and Ken.
5. Back in 2016 a PayPal account was set up to be used for our lacrosse club transactions. In the Fall 2020 it was brought to our attention that we still had a PayPal account with money left in it. Jeff Larkin investigated and found that the account had been hacked. In June of 2017, \$2700 was transferred out of the account to an unknown source. At the end of 2020 we closed the PayPal account and transferred \$60.39 to our current bank account.

GMHS Weight Room: Coach German upgraded the schools weight room. He is asking for all sports to give \$1500 toward the upgrade. Nate has reached out numerous times to Coach German to discuss. Coach German has not responded. We are willing to give but need to come to an agreement on the amount. Because of our short season and lack of fundraising we are deferring this donation until the 2022 season.

Winter League:

- a. Still need to collect some payments. Some parents paying via Venmo

- b. Facebook Live: we started Live Streaming the games on FB. “Live Green Mountain Boys Lax” on Facebook to watch streaming. Cindy Sark set this up. Feedback is positive. The quality of the streaming is good and parents and grandparents are loving it!
